**2. Board Issues**

Dr. Bernstein welcomed two new Board members: Maureen Bogosian, Public Member, and Matt Greenberg, MD.

Dr. Bernstein thanked the members for allowing him the privilege of serving as Chair of the Board.

**4. Election and Presentation of New Board Officers:**

Mr. Herlihy noted there was only one nominee for each Board Officer position and that the Nominating Committee approved a slate: Sarah McClain, Chair; Richard Hildebrant, MD, Vice-Chair; Marga Sproul, MD, Secretary.

Mr. LeCours made a motion to accept the nomination of Board Officers as presented by the Nominating Committee and elect the three nominees. Ms. Hunter seconded the motion. The motion passed; opposed: none; recused: none; abstained: Dr. Greenberg.

**5. Approval of the Minutes of the January 5, 2022 Board Meetings:**

Dr. Hildebrant moved to accept the minutes of the January 5, 2022 meeting. Ms. McClain seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

## **6. Administrative Updates (Mr. Herlihy):**

Mr. Herlihy provided a brief update on the result of the physician assistant license renewal. 464 PAs renewed, but approximately 30 had not. It appeared that none of the PAs whose licenses expired were working in Vermont after their licenses expired. He added that there was not yet information about the status of those who lapsed.

## **7. Presentation of Applications:**

Applications for physician, physician assistant and limited temporary physician licensure were presented and acted upon as detailed in Appendix A, incorporated by reference into these minutes.

Dr. Bernstein asked for a motion for the issuance of physician licenses and physician assistant licenses. (See Appendix A)

Dr. Hildebrant made a motion to accept all applicants for licensure as presented. Seconded by Ms. McClain. The motion passed; opposed: none; abstained: none; recused: none.

Dr. Bernstein asked for a motion for the issuance of limited temporary licenses to practice medicine. (See Appendix A)

Recommended by Dr. Hildebrant for licensure. Seconded by Dr. Tortolani. The motion passed; opposed: none; abstained: none; recused: none.

## **8. Other Business:**

Mr. Herlihy thanked Dr. Bernstein for his leadership as Board Chair and noted that Dr. Bernstein would continue to serve as a physician member of the Board. Mr. Herlihy also extended congratulations to Ms. McClain, Dr. Hildebrant, and Dr. Sproul and thanked them for stepping up into these roles.

Mr. Herlihy referenced an email he sent to members summarizing proposed legislation that may be of interest to the Board. (See Appendix B) Updates covered bills as follows:

Two scope of practice issues that have previously been in the Legislature and that the Board has commented on have come up again. S.158 concerns the scope of practice of optometrists; it proposes to allow them to do procures. Unlike a past proposal, which had listed procedures that would be allowed, this bill would allow optometrists to perform procedures except for those listed in the bill. Mr. Herlihy indicated that the Board had opposed the prior proposal and could continue to rely on that as the Board's position. He asked if any members wished to revisit the issue; no members asked to further discuss the issue. The other scope of practice issue is in H.392, which proposes expansion of the scope of practice for certain doctoral-level psychologists to allow prescribing. He advised that a report to the Legislature by OPR on the issue is expected. If the report disfavors expansion of the scope of practice it will not be dispositive, but will influence the Legislature's decision. Mr. Herlihy advised that as with the

other scope issue, the Board had recently passed a motion opposing the proposal and that he would rely on that at this time and keep the Board informed of developments.

Also of interest are H.654 and H.655. The two bills reflect the recommendations of the Interstate Telehealth Work Group. H.654 focuses on the immediate extension of COVID-19 emergency measures, including those relating to licensing of health care professionals. There are some adjustments to the emergency provisions allowing health care professionals to work at facilities in Vermont; most notably it limits the amount of time that an individual can work in Vermont under the COVID provision to a 6-month period. Time before passage of the bill would not count toward the 6-month limit. The bill also adopts the recommendations of the Telehealth Work Group by requiring all those performing telehealth without a Vermont license to become registered by April 1, 2022. H.655 further adopts the Telehealth Work Group's recommendations by proposing to create the two new proposed licensing categories for telehealth effective on July 1, 2023. Those are a very limited telehealth registration option and a limited telehealth license. H.654 had been passed by the House on January 28<sup>th</sup> and H.655 was moving toward passage.

Mr. Herlihy also noted *S. 206 – An act relating to planning for the care and treatment of patients with cognitive impairments*. There is an existing Commission on Alzheimer's Disease and Related Disorders. The bill is of interest because it includes a provision that would add to the duties of the Commission by having three Commission members appointed to a work group to make recommendations regarding CME requirements related to the diagnosis, treatment, and care of patients with cognitive impairments, including Alzheimer's and other forms of dementia. Vermont law already covers two topics that are required for CME (opioid prescribing and hospice/palliative care/pain management) and there is another study taking place to consider CME requirements for equity and diversity in health care.

Members expressed concerns about adding another required subject. It was noted that these requirements are piling up and having a group of required subjects is at the expense of other training that physicians need. Other comments brought up the ineffectiveness of one-time CMEs and the percentage of licensees who have little or no contact with the relevant population. Mr. Herlihy noted that he has a clear sense of the Board's concerns if he is called to testify.

Mr. Belcher first asked about who would be acting as Chair because Dr. Bernstein had already been recused from the matter during the hearing process and Ms. McClain had been a member of the Hearing Panel. It was established that Dr. Sproul would be *ad hoc* Chair. Mr. Belcher then established on the record that the Respondent and his attorney had indicated that they would not participate in the hearing and that they were not present. He then invited Ms. Campbell to address the Board. She made a presentation asking the Board to approve the Findings, Conclusions of Law, and Order recommended by the Hearing Panel. The Board considered the Report, the evidence, the record, and the other material that was filed with the Board. The Board announced that it was ready to announce its decision. Mr. Belcher advised that there were two typographical errors and a request from Respondent to amend the wording of Finding 32; he advised correcting the errors and determined that there was no objection by Ms. Campbell to Respondent's request regarding Finding 32.

Ms. Falk made a motion to adopt the Findings of Fact and Conclusions of Law as submitted by the Hearing Panel, but with the amendments to correct two typographical errors and revise Finding 32 as requested by the Respondent, and to Approve and Enter the Recommended Order. Dr. Clattenburg seconded the motion.

Hello Everyone –

This is to provide some information about the bills that will be discussed at Wednesday’s meeting. For the most part this is only informational at this time. The exception is the second item, S.206. That is being discussed and the Board might want to take a position on it.

[S.158 An act relating to optometrists’ scope of practice](#) - This issue was discussed as part of a bill during the 2019-2020 session; the proposal to expand the scope of practice of optometrists to allow certain procedures was not passed. That followed a study and report by OPR on the issue that did not recommend passage. That report has not been changed. This bill goes further than the earlier proposal in that rather than listing certain procedures that are allowed, it authorizes optometrists to perform procedures except for listed categories of procedures that are excluded. In 2019 the Board passed a motion expressing opposition to the proposal because of patient safety concerns. Those concerns were based on the significant differences in education and training between the professions, and also on the lack of evidence of any access to care problem that might justify the risks. The Senate Government Operations Committee took testimony on the bill on Thursday, January 27<sup>th</sup>. The Committee Chair and some members seem to favor the bill; it is unknown at this time if the Senate Health and Welfare Committee would support it.

[S.206 - An act relating to planning for the care and treatment of patients with cognitive impairments](#) – there has been a Commission on Alzheimer’s Disease and Related Disorders since 1999. The Commission is part of the Agency of Human Services and its role is to advise state agencies on matters of State policy relating to Alzheimer’s disease and other dementia-related disorders in Vermont. I’ve not previously mentioned this bill. It was recently introduced and the Senate Health and Welfare Committee is taking testimony on it for the first time tomorrow, February 2<sup>nd</sup>. The bill is of interest because it includes a provision that would add to the duties of the Commission by having three Commission members appointed to a work group to make recommendations regarding CME requirements related to the diagnosis, treatment, and care of patients with cognitive impairments, including Alzheimer’s and other forms of dementia. Vermont law already covers two topics that are required for CME (opioid prescribing and hospice/palliative care/pain management) and there is another study taking place to consider CME requirements for equity and diversity in health care.

[H.392 An act relating to prescribing by doctoral-level psychologists](#) - this was discussed last year and the Board passed a motion stating opposition to the concept; that was presented during a study conducted by OPR to consider this requested expansion of the scope of practice of doctoral-level psychologists. The report of the OPR study is expected to be released at any time. There has not been any activity on this bill yet during the current session. The Board of Psychological Examiners passed a motion on this issue at its December 10, 2021 meeting. The minutes of the meeting show: *Dr. Huitt moved, seconded by Dr. Turcotte, to approve the following statement regarding the petition to expand the scope of practice for doctoral psychologists in Vermont to include prescribing*

*authority: "The Board opposes H. 392 as currently drafted and to state that the legislative efforts in Iowa and Illinois, which include enhanced educational requirements, enhanced supervision requirements, and population limits, offer benefits to the public that justify associated risks. The Board is also concerned that establishing laws distinguishing the scopes of practice of masters and doctoral level licensees undermines the original legislative intent that these licensees have the same scope of practice. Should the legislation be amended, the Board would appreciate the opportunity to review it again and offer its perspective." Motion approved.*

[H.654 An act relating to extending COVID-19 health care regulatory flexibility](#) - This link is to the version of the bill that was passed by the House on Friday, January 28th. It addresses many different aspects of health care. The portions of most direct interest to the Board begin a page 8. Generally, it extends the provisions that have allowed health care professionals licensed in other states or who left active practice in Vermont recently to practice here through March 31, 2022, however there are some adjustments as noted below.

- It cuts out the authorization for out-of-state health professionals to practice by telemedicine and moves that to a separate section later in the bill. There is language on pages 17-18 that for telemedicine covers the period from passage to March 31, 2022 and then on pages 18-19 it provides for the Board and OPR to register out-of-state licensed health professionals from April 1, 2022 through June 30, 2023. That temporary registration is to provide a transition period for all those health care providers who are currently providing telehealth services in Vermont pursuant to the special COVID exemptions. The long-term plan for telemedicine is addressed in H.655.
- The provision allowing out-of-state professionals to practice here with the Medical Reserve Corps, in licensed facilities, and FQHCs is extended through March 31, 2022, however, for all but those practicing with the Medical Reserve Corps, it is limited to a period of 6 months beginning from the effective date of the bill. The limit of six months was added to address those who have taken permanent jobs here and just not bothered to become licensed yet. The MRC volunteers were not included in that limiting provision because they are volunteers and engaged in well-defined and highly structured practice.

[H.655 An act relating to establishing a telehealth licensure and registration system](#) - the link is to the latest version of the bill being discussed in the House Health Care Committee. This bill would enact the recommendations of the Telehealth Work Group. The overall concept is to provide two new options that would allow telemedicine practice. One is a telehealth license that would have a lower fee and, to the degree established by the Board through rules, could have less of an application process. The telehealth license would be good for the same licensing period as the full license and would be renewable. It would be limited to 20 Vermont patients. The registration option would be for a fee lower than the telehealth license and have a very limited application process. It would be good for only 120 days, would not be renewable until three years after issuance, and would allow for practice with a total of only 10 patients. For the Board these two new options would be available only to MDs, podiatrists, and PAs. It does not include AAs and RAs. When asked about the professions that should be included AA and RA were left out. There are two main reasons for that. First, given the nature of their practice, there is little potential for someone to engage in

practice only using telehealth. An AA or RA who has a full license in Vermont might have some patient interactions by telehealth, but that probably would only be an extension of in-person services. Second, unlike PAs, for AAs and RAs their authority to practice is derived from their supervising physician and supervision is quite close. At the end of the bill there is a section that would give OPR the ability to issue provisional licenses to applicants who are missing certain, limited pieces of documentation. As decided by the Board last month, we did not ask for the BMP to be included in that section.

There are many other bills that relate to health care in one way or another. This list is limited to those bills that are of most interest and that have some prospect to “come off the wall” and be discussed in at least one Committee.
