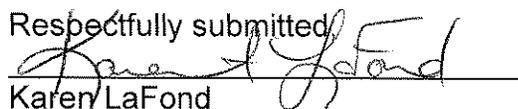
5. Next Regular Board meeting: January 5, 2011, 12 p.m., Gifford Medical Center, Randolph, Vermont.
