Approval of the Minutes of the July 5, 2023, and July 19, 2023, Board Meetings:

Dr. Tortolani moved to accept the minutes of the July 5, 2023, and July 19, 2023, meetings. Dr. Bernstein seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

• Board Issues (Dr. Hildebrant):

Dr. Hildebrant reminded the Board that this year, Sarah McClain will be leaving the Board. D. Herlihy offered a farewell and thanks to S. McClain for her services as a member of the Board. D. Herlihy reminded the Board that S. McClain began with the Board in 2011 and shared appreciation for the time S. McClain has spent with the Board.

Administrative Updates (David Herlihy):

- D. Herlihy mentioned that last month a mass email was sent out to all Board licensees. The information contained in the email included: a new requirement by the DEA for training in order to renew DEA registration; change to a Vermont Department of Health form required when a patient uses the End of Life Law; a note about how the Board deals with licensees' personal health issues and participation in Vermont Practitioner Health Program; and a free CME opportunity on Xylazine. J. Malago shared statistics on the delivery, receipt, and engagement of the message by the licensees.
- D. Herlihy shared that the Limited Temporary License (LTL) renewal period ended in June. J. Malago shared statistics and demographics about this year's initial and renewal LTLs
- D. Herlihy provided a reminder that August 16th is the Battle of Bennington state holiday, resulting in the mid-month and South Committee meetings to be held on August 23rd instead of the 16th.

• Presentation of Applications:

Applications for physician, physician assistant and limited temporary physician licensure were presented and acted upon as detailed in Appendix A, incorporated by reference into these minutes.

Dr. Hildebrant moved for the issuance of physician licenses and physician assistant licenses. (See Appendix A)

- D. Herlihy presented information about VPHP's draft clinical policy on cannabis use.
 VPHP Medical Director Dr. Kloster was present to answer questions and further discuss the draft language. Dr. Kloster stressed the desire for input from the Board particularly referencing paragraph two of the draft. Board members had not received a copy of the draft for review prior to this meeting and decided to table the discussion and decisions for further review in the September meeting.
- D. Herlihy provided the Board an overview of the Dr. Lorna Breen Heroes' Foundation, the work the foundation does to counter physician burnout and support physician wellness, and the suggestions they made for modifications to the wording of certain items on Board's application forms. The ad hoc committee working on licensing process review had met on July 28 and reviewed the suggested changes; the committee's recommendations were presented to the Board:
 - On the application reference form document, remove the question "Do you know of any emotional disturbance, mental illness, organic illness, alcohol, or drug problem, which might impair the applicant's ability to practice" and replace it with "Are you aware of any reason that this person cannot currently practice medicine safely?"
 - In the application document, change the definition of currently from
 "Currently This term means recently enough that a reasonable person
 knowledgeable about substance use disorder and informed about your use
 of substances would find a risk to patients arising from that use" to
 instead read "Currently This term means recently enough that your use
 of substances would pose a risk to patients."
 - In the application document, change the questions "Do you have a medical condition that in any way impairs your ability to practice medicine in your field of practice with reasonable skill and safety?" and, "Are you currently engaged in the use of alcohol or other chemical substances that in any way impairs your ability to practice medicine in your field of practice with reasonable skill and safety?" to remove the term "in any way" and instead read "Do you have a medical condition that currently impairs your ability to practice medicine in your field of practice with reasonable skill and safety?" and "Are you currently engaged in the use of alcohol or other chemical substances that impairs your ability to practice medicine in your field of practice with reasonable skill and safety?"


