

2024 Nurse Staffing Data

Nurse staffing is measured by nursing care hours per patient day (the number of nursing care hours relative to the patient workload). This measure was developed by the American Nurses Association for the National Database of Nursing Quality Indicators.

There is no national standard for optimal nurse staffing level. This is due to varying factors like intensity of patient's needs, the number of admissions, discharges and transfers during a shift, level of experience of nursing staff, layout of the unit and availability of resources (ancillary staff, technology etc.).

Second Floor Medical-Surgical Unit (MS2)

The second floor Medical-Surgical Unit (MS2) serves a predominantly surgical patient population as well as occasional medical patients. The unit consists of 8 licensed beds and is open Monday through Friday.

Progressive Care Unit

The Progressive Care Unit (PCU) has 24 licensed beds, which includes 5 monitored beds, and was created by merging the Special Care Unit and Third Floor Medical Surgical Unit in May 2017. The PCU is an acuity adjustable unit providing care to a diverse patient population requiring medical-surgical and telemetry levels of care, as well as a select group of patients requiring a higher level of care.

Birthing Center Unit

The Birthing Center is a Level 1 Low-Risk Birthing Center utilizing single-room maternity care. The patient population includes obstetrical patients (antepartum, intrapartum, postpartum), select female surgical cases, newborn infants, and infants readmitted during the neonatal period. The Birthing Center has 21 licensed beds, which includes 10 adult and 11 nursery beds. Cesarean sections are performed in an Operating Room located within the Birthing Center.
