Approval of the Minutes of the October 2 Board Meeting and October 7, 2024, Special Meeting

S. Tucker moved to accept the minutes of the October 2 and October 7, 2024, meetings. Dr. King seconded the motion. The motion passed; opposed: none; recused: Dr. Eyler for the Oct. 7 meeting; abstained: none.

Administrative Updates (David Herlihy):

Renewal Progress – data about renewal processing was shared with members.

The renewal period began on August 30, 2024 with 6077 MD licensees.

As of November 5:

3811 processed and issued (3002 Regular and 809 IMLC)

2266 still to be submitted (1568 Regular and 697 IMLC)

Staff members Ron Hunt, Marcy Quinlan, and especially Tracy Hayes were recognized for all their hard work getting so many renewals issued.

• Other Business:

Board Officer Nominations and Election

Members were asked to volunteer to be on a Nominations Committee to propose a slate of nominees to the Board. Suzanne Jones, PA-C; Judy Scott, and Dr. King volunteered. Members were advised that the current officers, Dr. Hildebrant, Dr. Greenberg, and Dr. Tortolani are willing to continue to serve in their current roles. Members were invited to self-nominate to run for a position or nominate another member by emailing the Executive Director.

• APRN Subcommittee Representative

David Herlihy provided background about the need to designate a physician to represent the Board on the Board of Nursing's APRN Subcommittee. Dr. Tortolani indicated that he would volunteer for the role. (**Note**: Subsequent to the meeting Dr. Ireland expressed interest in being designated and after further discussion it was agreed that Dr. Ireland would be the Board's designated physician representative.)

Draft Guidance Document from the Advisory Commission on Additional Licensing Models

Dr. Hildebrant noted that there was a request put out for comments on the draft guidance document issued by the Advisory Commission on Additional Licensing Models. The deadline for submission is December 6, 2024, so the Board will be able to decide on whether to submit comments at the December 4 meeting. The

group reviewed the recommendations set forth in the guidance document. Dr. King made a comment on Recommendation 3, which provides that States should require ECFMG for the group of international physicians being discussed. She noted that each of the three elements that must be satisfied for ECFMG Certification – Graduation from a qualifying medical school, passing USMLE Steps 1 and 2, and demonstrating English language proficiency by passing the Occupational English Test Medicine – is essential for screening candidates. Because the USMLE requirements might change, she proposed that the recommendation should be expanded to set forth the underlying elements.

The Draft Guidance Document from the Advisory Commission will be on the agenda again for the December meeting. Any member desiring to share additional thoughts with other members in advance of the December meeting may email them to the Executive Director to be distributed with the December agenda.

In re: Keri McFarlane Bentley, MD – State's Motion for Reciprocal Discipline pursuant to 26 V.S.A. @ 1420j(c)(1) – Docket # MPN 131-0423

Dr. Hildebrant convened the hearing, with K. Kuehl, AAG, representing the State. Dr. Hildebrant asked if Dr. Bentley had been notified of the hearing; K. Kuehl stated that notices had been sent to her via both regular first-class mail and by certified, return receipt mail, and that along with the addresses that Dr. Bentley had provided to the Board, the notice had been set to addresses found in orders concerning Dr. Bentley issued by other state medical boards, as well as to the email address on file with the Board. Dr. Hildebrant inquired if Dr. Bentley was expected to participate in the hearing; K. Kuehl responded that she had not contacted the Board and that it was noted in other state medical board actions that she had not appeared for hearings. Dr. Hildebrant invited K. Kuehl to present the matter. K. Kuehl addressed the Board, summarizing the facts leading up to the Order of Revocation and the discipline set forth in the proposed Order. Dr. Ireland asked about the provision in the Kentucky Order that if Dr. Bentley's Kentucky medical license is ever reinstated that it would be contingent on her entering an agreed order that she is permanently banned from prescribing controlled substances. Dr. Ireland asked whether there should be a similar provision added to the Order concerning possible reinstatement of her Vermont medical license. Dr. Greenberg made a motion to approve the Order of Revocation as set forth in the State's Motion but with

> a provision added stating that if her Vermont medical license is ever reinstated it shall be contingent upon her entering into an agreed order that she is permanently prohibited from prescribing or dispensing controlled substances. Dr. Odigie seconded the motion.
