• Approval of the Minutes of the July 3, 2024, Board Meeting:

• Board Issues (Dr. Hildebrant):

The Chair welcomed the Board's newest member, Dr. Peter Ireland, who will be on the Central Investigative Committee, and invited him to introduce himself to the other members.

• Administrative Updates (David Herlihy):

The Executive director shared the following:

- A mass email was sent to licensees on August 2. It included an announcement about the Joint Statement on IV Clinics, information about new guidelines on how to determine death, and a reminder about the upcoming physician renewal.
- Recruitment for the new position was completed. Marcy Quinlan will be starting on Augst 12, 2024.
- The Board office will be closed August 16, 2024, for Bennington Battle Day, which is a state holiday. The Central Committee meeting will occur on August 23, 2024, a week later than normal.
- The North Investigative Committee will be in person this month on Thursday, August 15, 2024, at the Health Department lab building in Colchester.
- Members who volunteered for the ad hoc Committee to revise the Board's Policy on prescribing opioids will be contacted soon about scheduling a meeting to review a draft.

Other Business:

David Herlihy presented the proposed draft of changes to the Board's administrative rules. Before the discussion of the details, it was noted that this set of changes was prepared mainly to implement revisions to the licensing process that resulted from a review conducted during the fall of 2023 that led to a series of motions that were passed in November and December calling for modifications to the process. Mr. Herlihy added that another issue reflected in the draft is the Board's decision to increase the nondisciplinary financial penalty for the failure of a licensee to maintain current contact information with the Board. Members were reminded that while the Board is asked to approve these changes, these are actually agency rules; once a draft of the changes has been approved by the Board there will then be a process that includes review by the Department of Health and Agency of Human Services, public notice and hearings, and review by the Legislature Committee on Administrative Rules. The Executive Director went through the changes as listed in the document attached to the agenda.

The discussion of Rule changes was paused to conduct the scheduled hearing.

Judge invited Bill Reynolds AAG to present the matter. Bill Reynolds AAG addressed the Board, summarizing the facts leading up to the Cessation of Practice.
