#### Approval of the Minutes of the September 4, 2024, Board Meeting:

Dr. Coddaire moved to accept the minutes of the September 4, 2024, meeting. Dr. King seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

#### Administrative Updates (D. Herlihy):

- MD Renewal Progress. As of August 30, there were 5846 MD licensees. As of October 1, there had been 1,592 renewals submitted; 1165 of those were processed and issued.
- Alternative Pathways for Foreign-Trained Physicians. D. Herlihy met on September 30 with a group convened by Senator Wendy Harrison of Windham and Rep. Leslie Goldman. A number of advocates interested in the FTP issue and two individuals with World Education Services also participated. WES is a non-profit that promotes recognition of overseas education and support of immigrants in having their education and qualifications recognized. The group wants to have a bill during the coming legislative session. A report prepared by a group convened by Massachusetts to discuss pathways for FTPs was discussed. A copy will be shared with members.
- D. Herlihy and Dr. Odigie participated in an October 1 meeting convened by the Federation of Podiatric Medical Boards about efforts to create an interstate compact for podiatry licensure that would be modeled on the IMLC.

#### Other Business

• Informational Presentation on Naturopath Education and Training
Dr. Steven Moore, Chair of the Legislative Committee of the Vermont
Association of Naturopathic Physicians, presented information about
the education and training of naturopathic physicians. The purpose
was to better inform the Board to offer input to the Technical Advisory
Group created by Act 158 of 2024 that will be providing advice to the
Commissioner of Health, who will be making recommendations to
legislators on the potential integration of naturopathic physicians into
the processes for Vermont's Patient Choice at End of Life law, do not
resuscitate (DNR) orders and advanced directives, and the creation of
clinician orders for life-sustaining treatment (COLST). Many members

had questions and comments. The discussion ran well over the scheduled time, and it was noted that members had not had an opportunity to review written materials about naturopathic physician education and training that were obtained by the Board just before the meeting. It was decided that a special meeting would be held on October 7, 2024 to continue the discussion.

## • Vermont Practitioner Health Program (VPHP)

Representatives of the Vermont Practitioner Health Program provided an overview of the program's operations. The group included: Nels Kloster, MD, VPHP Medical Director; and Colleen Magne, VPHP Program Administrator; Jessa Barnard, Executive Director of VMS; and John Valentine, MD, Chair of the VMS VPHP Committee. It was agreed that the Board and VMS/VPHP will soon schedule a liaison meeting.
