This fact suggests that the expansion of education regarding, and access to harm reduction measures could have a significant impact on morbidity and mortality from Opioid Use Disorder (OUD). Health Care & Rehabilitative Services, Inc. (HCRS)

HCRS is the community mental health and developmental services agency for Windsor and Windham Counties of Vermont. Founded in 1967, our non-profit agency serves over 4,000 individuals annually through its key programs for mental health, substance abuse, and developmental disabilities.



Groundworks Collaborative

Groundworks Collaborative was established in 2015 following the merger of two well-established organizations: the Brattleboro Area Drop-In Center and Morningside Shelter (having previously been in existence for 27 and 36 years respectively). We work with people and systems creating solutions to end hunger and homelessness for all people in our region.




Better Life Partners

Program Activities

- Peer Support People with lived experience with Opioid Use Disorder identify and screen individuals at risk for SUD/OUD and co-occurring disorders disorders/infectious complications (including HIV, viral hepatitis, mental illness, etc.), and provide, or make referrals to, prevention, harm reduction, early intervention, treatment, and other support services
- Wrap-around services in the emergency shelter and Permanent Supportive Housing (PSH) sites
- Relapse prevention within the Groundworks Drop-in shelter and PSH sites through skill development, recovery groups, and process facilitation in restorative practices with participation from individuals experiencing housing insecurity and SUD

Program Activities: Connecting Resources

- Creation of Outreach League outreach specialists from HCRS, Groundworks, Turning Point, the AIDS Project, and the Brattleboro Police Department share joint calendar of activities, meet twice monthly to harmonize outreach efforts, highlight new capabilities
- Rapid formation of Tents For Hope fundraiser to provide emergency shelter until December 1 to the unhoused losing vouchers in the GA Emergency Shelter program
 - Solicited approximately \$2000 in donations from individuals, faith-based organizations
 - Funds matched by HCRS
